• Great Gransden 20MPH Zone - Formal Consultation – update – (Cllr Catmur)

22/11/2022 CCC Highways

Text below within email from Steven Thoday, CCC Highways.

With regard to requests to extend the boundary of the 20mph zone further on Eltisley Road, Caxton Road and Sand Road or to install a 30mph speed limit buffer. Due to the more rural nature of these sections of road with no properties fronting onto the road there is likely to be minimal compliance with a lower speed limit of 20mph or 30mph here.

Cambridgeshire County Council's existing policy is that 20mph speed limits will be considered on sites where existing mean speeds are 24mph or less or where additional speed reduction measures will achieve a mean speed of 24mph or less. The Police are unlikely to support schemes unless the current mean speeds are below 24mph or unless proposals are accompanied with traffic calming measures to ensure speed limits are self-enforcing and largely compliant.

The comments we received were mixed but most seem to be making the following points.

- The proposed entry point on Meadow Road should be closer to the Waresley Road junction and be at the existing 30MPH signs
- The proposed entry point on Eltisley Road should include property number 22 and be at the existing 30MPH signs

In light of the comments received we have made the following changes to the original design.

- The entry point on Meadow Road has been extended to the current 30MPH signs
- The entry point on North Street has been extended to the current 30MPH signs
