What is EPDM? Ethylene Propylene Diene Monomer (M-class), or EPDM, is a synthetic rubber that is extremely durable and used across a variety of applications.

I have asked the question (about 'rubber' washers) from the fence manufacturer regarding what it is made from, but the fencing manufacturer was Zaun.

- a) Backboards replace with sound reduction material to include wording "DO NOT CLIMB OR HANG ON THE RING" Sadly having spoken to the existing manufacturer, there isn't a possible backboard available that "reduces noise" and we are unable to retrofit other backboards.
- b) Reduction of noise of fencing fit rubber inserts on fence at both ends of the MUGA. To provide labour to take down existing clamp bars that secure the mesh panels to the post, supply rubber inserts to go behind the panels and re-bolt. A mobile scaffold tower will be required for this Goal Ends ONLY £780.00 + VAT / All of the MUGA £975.00 + VAT

Speed limit change

Description

Lower the speed limit on Meadow Road approaching the village from the West, from the village boundary to the current 40mph boundary (500m), as: traffic levels will increase substantially during A428 construction; there are 8 driveway entrances within the zone; and there have been 3 accidents in the last 5 years.

Known safety issue

Data shows 2 'slight' (2021 and 2018) and 1 'serious' (2020) reported accidents over 5 years on this 500m of road. Clearly data captured does not record all minor accidents, so more 'slight' may have occurred. We believe that the accidents may be related to the 60mph speed limit, curved nature of the road (with a small hill) and the 8 driveway entrances on the section of road. It should be noted that there is no footpath, so residents who walk are required to walk on the road/verge.

Safety increase

A lower speed will help make entering and leaving the driveways easier. It will also benefit pedestrians walking along the road/verge and cyclists using this road (it is a popular cycle route).

Public health

At the moment residents tend to drive to the village, and lower limits will encourage them to walk/cycle to the village centre.

Local support

The Parish Council has had regular correspondence from residents asking for lower speed limits and a footpath on Meadow Road (see parish council minutes of March 2023 for the latest). Speed limits and lack of a footpath on this road are a regular item in parish council minutes. During preparation of the village NDP speeding was raised as the most significant item of concern. The Parish Council agreed to support this LHI bid at its meeting of 3/4/23.

Environment

The main benefit will be a positive reduction in vehicle speeds at the edge of the village and the resultant reduction in car usage by residents.

I have reviewed the case and can see that application 22/00879/S73 for 'Variation of condition C20 (off site works as per plan prior to commencement) for 17/01375/OUT to reconcile the approved planning drawings pursuant to condition 20 with the associated completed off-site Section 278 works' was approved by Committee in September 2022, with the decision issued 3th October 2022.

As this application was approved the breach is regularised and the case will be closed.
