'It seems that the scheduled work for this visit is for two <u>man</u> days (only today because there are two of them). The fence work did not seem to be on their list–just a standard pressure wash and whatever.

'Peter and Richard did look at the panels on my map (which they hadn't seen) and quickly located several loose and missing bolts. They were happy to tighten these under the day's work but did not bring any replacement rubber pads and only had a couple of the right bolts (just by chance). In fact they were expecting a chain link fence and had not been briefed about the noise problem at all. They will do what they can reach with their ladders; they did not bring scaffolding.

- 1. 'This is not the overhaul job that was quoted for by Rory Peter said that would be a follow up job if needed and would entail a survey, procurement of new parts and a separate visit with scaffolding.
- 2. 'Today's tightening of a few loose bolts is a minor piece of work that they said would be included in the original service price (obviously tbc by Rory).

'Hopefully the "quick fix" solves the problem, but if not, I would be grateful if you could press for an early date for the special work.'


