17.1 Bowls Club event and car parking 18th July.

We are writing to seek the Parish Council's approval to park some cars on the grass strip leading to the Playing Field behind the Reading Room on Thursday the 18th July 2024.

On the afternoon on the 18th July the Gransden Bowls & Croquet Club have invited the Cambridgeshire Area of The Riley Register to a social event at the Club House. The invitation will also be extended to individuals in Great Gransden and neighbouring villages who also own old cars. Refreshments will be provided and guests will have the opportunity to play croquet. We are hoping that the event will help to raise much needed funds to support the development of the Gransden Bowls & Croquet Club.

We anticipate that around 20 or more old cars will attend, so the car park behind the Reading Room may be insufficient. If this is the case, please may cars be parked on the strip of grass to the west of the Muga that leads to the Playing Field? People would be asked to park alongside

the hedge, not next to the Muga fence, and we will ensure there is adequate emergency access to the Playing Field.
