"My suggestion is that the light should be permanently removed following a review of its utility. From my perspective its only function is to bathe my house in light pollution during the winter months (it is situated directly in front of an upstairs window). It causes moss to grow on the outside, damaging my property. It (dimly) illuminates a 20m stretch of pavement that has no route to it or from it. Presumably it was installed to highlight the roundabout, but it fails in this miserably due to poor design and placement. It serves no purpose now modern car headlights are so much improved and presumably costs the parish council to maintain and power it. This is a waste and I would ask that it is reviewed with a view to removal."

  - 30/1/25 Mill Lane ditches overflowing across road after rain from a resident.
    "The ditches on the right hand side, as you look down from the windmill, are never cleared, leading to running water down the hill and standing water both by the windmill and at the bottom by the lay-by/garden of 31 Mill Road.

The blocked ditches are a hazard to drivers, cyclists and pedestrians, especially when it is icy and when it has rained heavy.

Whose responsibility is it to clear these ditches and can the council request they are cleared out so that the water can flow in them and not on the road please?

In addition the drains on Mill Road always seem to be full and blocked. I have taken a few photos to demonstrate what I am emailing you about."

from a resident

"....in two areas in particular it is no longer possible to walk on the footpath because hedges etc have been allowed to widen to such an extent the only way is by walking on the road. Walking a dog or pushing a push chair in these two areas would be totally impossible.

The <u>first area</u> is outside 21 Church Street where the hedge is well trimmed but has got to such a width it is some way across the footpath. This hedge needs to be taken right back to allow pedestrians to walk on the path.

The <u>second area</u> is at the bottom of crow tree street on the right hand side just next to the junction. The problem there is rosemary bushes. This is particularly dangerous as the path is right next to the junction and cars come from

Meadow Road direction and turn left into crow tree street. This means pedestrians are certainly at risk if walking on the road.

Please could councillors contact the home owners to rectify this situation which has been on going now for a long time."
